Whenever vacancy occurs on board, existing governing board shall submit a list of the following: (1) at least 1 but not more than 3 candidates for each vacancy to be filled by the appointing authority; (2) qualifications for assessment of candidate. For each vacancy, the appointing authority may: (1) appoint 1 of the candidates submitted by the governing board; or (2) request and receive from the governing board a second list of at least 1 but not more than 3 candidates; or (3) appoint an individual who meets the requirements concerning board members and who was not named in the initial list submitted by the governing board.</i></p> <p><i>No mention about political affiliations in IC although hospital board bylaws state not more than 3 members may be of same political party (section 3.4 of bylaws).</i></p>
