

PERRY COUNTY COMMISSIONERS

APPOINTMENTS EXPIRING YEAR-END 2019

Any interested persons wishing to serve on boards are to submit letters of interest the County Administrator either by mail at 2219 Payne Street, Tell City, IN 47586, or by e-mail at CountyAdmin@perrycounty.IN.gov.

Letters of interest should be received on or before Friday, December 27, 2019.

More information about the appointments listed below may be found in the referenced Indiana Code (IC).

ALCOHOLIC BEVERAGE BOARD 1 appointment, 1-year term IC 7.1-2-4

- Must be at least age 21.
- Must be a resident of the County for at least 5 years.
- Must not have a felony conviction within past 10 years.

CONVENTION, RECREATION & VISITOR PROMOTION COMMISSION 3 appointments, 2-year terms IC 6-9-18

- Must be resident of the County.
- Need not be resident of County if owner or executive level employee of a convention, visitor, or tourism business located within the County. In this case, the person must be resident of Indiana.
- If available and willing to serve, at least 2 of the 11-member Commission must be in business of renting or furnishing rooms, lodging, or accommodations.

HEALTH BOARD 2 appointments, 4-year terms IC 16-20-2

- Due to the current make-up of the 7-member board, 1 appointment must be a licensed physician, and 1 appointment must be knowledgeable in public health from any of the following categories:
 - Registered nurse
 - Registered pharmacist
 - Dentist
 - Hospital administrator
 - Social worker
 - Attorney with expertise in health matters
 - School superintendent
 - Veterinarian
 - Professional engineer
 - Environmental scientist
- Political affiliation requirement: Due to the political affiliations of the current board membership, interested persons from any political party may submit letters of interest; however, no more than 1 of the 2 appointments can be from the same political party.
- Must be a resident of the County.
- Must be a U.S. citizen.

PERRY COUNTY MEMORIAL HOSPITAL ASSOCIATION 2 appointments, 4-year terms IC 16-22-6

- Must be residents of the County.
- Political affiliation requirement: Due to the political affiliations of the current association membership, interested persons from any political party may submit letters of interest; however, no more than 1 of the 2 appointments can be made from the Republican party. Both appointments may be from the Democrat party.

PARKS AND RECREATION BOARD 1 appointment, 4-year term IC 36-10-3

- Must have interest in and knowledge of parks and recreation.

PLAN COMMISSION 3 appointments, 2 are 4-year terms; 1 is a vacancy with 1 year remaining IC 36-7-4

- Must be resident of unincorporated areas of the County, or a resident of the County who is also owner of real property located in whole or in part in an unincorporated area.
- Political affiliation requirement: Due to the political affiliations of the current membership, interested persons from any political party may submit letters of interest; however, no more than 1 appointment can be made from the Democrat party. All 3 appointments may be made from the Republican party.
- May not hold an elected office or any other appointed office in municipal, county or state government, except for membership on the Board of Zoning Appeals. (The vacant appointment was also appointed to the Board of Zoning Appeals.)

PORT AUTHORITY 2 appointments, 4-year terms IC 8-10-5

- Must be a resident of the County.

REDEVELOPMENT COMMISSION 3 appointments, 1-year terms IC 36-7-14

- Must be at least 18 years of age.
- Must be a resident of the County.

ZONING APPEALS 2 appointments, 1 is 4-year term, and 1 is a vacancy with 1 year remaining IC 36-7-4

- Must be a resident of the jurisdictional area of the Board, or a resident of the County and also an owner of real property located in whole or in part in the jurisdictional area of the Board.
- May not hold an elected office or any other appointed office, except for membership on the Plan Commission. (The vacant appointment was also appointed to the Plan Commission.)

INDIANA 15 REGIONAL PLANNING COMMISSION 2 At-Large appointments, 1-year terms IC 36-7-7

- Must be residents of the County.
- Must be knowledgeable in matters of physical, social, or economic development of the region.

TELL CITY PLAN COMMISSION 1 appointment, 4-year term IC 36-7-4

Since the City of Tell City exercises jurisdiction outside the City's limits, the Commissioners appoint 2 additional citizen members to the Tell City Plan Commission who live within or own property within the extended jurisdiction.

- Must be a resident of the unincorporated area in which the municipality exercises jurisdiction, or own real property located in whole or in part within the unincorporated area.
- Political affiliation requirement: This appointment must be a Democrat.
